For an explanation of membership classes, the membership benefits available, fees payable and so on, please see document **D1**. This application form **M3** for **Associate Membership** of BCA (and, optionally, membership of **BCRA**) is for use by outdoor activity service providers, businesses and similar 'corporate' bodies that wish to become members of BCA but which are not caving clubs or access controlling bodies. Individual staff of an organisation that is an Associate Member of BCA *do not* become members of BCA; they must join BCA as Individual Members if they so wish.

BCA membership runs for a calendar year and expires on 31 December each year. There is no discount for Associate Members who join part-way through the year, but they will be sent issues of periodicals that were published earlier in the year that they join. You may subscribe to BCRA's periodicals Cave & Karst Science (ISSN 1356-191X) and Speleology (ISSN 1478-999X) without becoming a member of BCA using form **M4**. This may be the cheaper option if you live overseas or do not need other benefits of membership. Other classes of membership are available – Direct Individual Membership (DIM; form **M1**), Caving Clubs (form **M2**), and Club Individual Membership (CIM), which is only available to individuals who apply via their caving club.

Unlike the other classes of membership, Associate Members *do not* receive insurance cover under BCA's third party public liability insurance scheme.

Methods of Payment

On-line payments by credit card or bank transfer

You may pay online at [caves.org.uk / payments / bca](http://caves.org.uk/payments/bca). You can use a range of credit and debit cards and you can also transfer money from your bank account.

Online registration of cheque payments

Even if you wish to pay by cheque, it helps our administration if you can complete the form at [caves.org.uk / payments / bca](http://caves.org.uk/payments/bca). You will receive an email confirmation and a reference number to write on the back of your cheque, which you can then post to us. For renewals, no further paperwork is required.

Cheques for back-issues of publications should be made payable to **British Cave Research Association** and sent to BCRA at the above address.

Cheques can only be accepted if they are in UK currency and drawn on a UK bank. For overseas customers this is usually possible if your bank has a branch in London, but you might be charged a large fee for obtaining such a cheque from your bank. We cannot accept any payment where a transaction fee has to be paid by the recipient. You should verify this before you send payment because, if our membership office cannot accept it, you may have wasted your transaction fee.

Postal payments by Credit Card

Payments by credit card must be made online. We regret that we cannot accept credit card payments by post or telephone.

BACS and International Bank Transfer

Organisations that wish to pay by BACS should contact us for details. Please quote your membership or reference number on any transfer. Overseas payments are possible using our IBAN and SWIFT codes.

Invoices

You can request a pro-forma invoice if your organisation requires one. You will receive this by email. You can then pay by cheque, or online.

The Small Print

Participation Statement – The BCA recognises that caving, cave diving and mine exploration are activities with a danger of personal injury or death. Participants in these activities should be aware of and accept these risks and be responsible for their own actions and involvement.

Privacy and Electronic Communications – If you agree to the use of your email address, BCA may send you the occasional item of news and information. Subscribing to this service will not un-subscribe you from BCA's paper newsletters. In accordance with the Privacy and Electronic Communications Regulations, only relevant messages will be sent, and provision will be made for members to opt out of such communications if they wish. BCRA's 'Notices' list is a

standard Internet mailing list where the customer has full control of his subscription and where such subscription indicates an agreement to the traditional operating practices of such lists.

Data Protection Policy – BCA will guard the data of its members, subscribers and other customers in accordance with the Data Protection Act (1998) and its Schedules. Personal data shall be obtained only for the specified purposes of i) administering membership, subscription and sales services and ii) mailing of items solicited by its customers. Additionally, email addresses will be stored for the purpose of administering web and email forums to which the customer has opted to subscribe and by such action indicated his agreement to any stated or implied terms and conditions.
